When necessary, the attention of Customs Officers, Police, and/or Immigration Officers is drawn to the following:

- The Classified Information comprising this consignment is classified in the security interests of the Kingdom of Spain and its allies and is protected by the Official Secrets Act 9/1968, amended by the 48/1978 Act, its Decree 242/1969, the Spanish NSA security laws and regulations and the security laws and regulations ratified by the Kingdom of Spain concerning International or Multinational Organizations.
- The consignment shall only be inspected by properly authorised persons.
- If an inspection of the consignment is deemed necessary, the following points should be complied with:
 - the inspection of the consignment is carried out in an area out of sight of persons who do not have a Need-to-Know, and in the presence of the Courier;
 - the Courier is assisted in re-packing the consignment immediately upon completion of the examination;
 - evidence of the opening and inspection of the consignment is provided by sealing and signing the outer envelopes or packages of the consignment after having them closed again and by detailing in the Shipment Documents that the consignment has been opened.
- Customs Officers, Police, and / or Immigration Officers of the country of origin or destination of the consignment, or countries to be crossed shall give assistance as necessary to assure the secure delivery of the consignment.

INSTRUCTIONS FOR THE COURIER

You have been appointed to carry / escort a classified consignment. Your "**COURIER CERTIFICATE**" has been provided to be used for the carriage of a classified consignment / escort of transport as detailed in the "Shipment Document and Final Declaration".

Before the transport takes place, you shall be briefed on your obligations regarding the transfer of classified consignments, and you shall sign the "**Briefing Declaration**" included below.

The following points are brought to your attention:

1. The person identified as the Courier (on page 1) is responsible for the consignment through the transport.
2. Throughout the entire transport, the consignment must in all circumstances, be kept in your personal custody unless it can be deposited in authorized places under secure conditions.

For safeguarding Classified Information during overnight stops, governmental facilities or industrial companies with the appropriate security clearance and authorisation may be used. .
3. The consignment will not be opened en route, and the contents must not be displayed or disclosed to third persons except in the circumstances described in paragraph 8 below.
4. You are not permitted to deviate from the agreed route and travel schedule unless explicitly approved by authorised persons.
5. In cases of emergency, you shall take such measures as deemed necessary to protect the consignment.
6. You shall ensure that you have all the necessary personal travel Documents (travel tickets, currency, medical insurance certificates or other necessary certificates), and that your expatriation and identification Documents (passport, visa, ID card) are valid.
7. The consignment will only be handed over or delivered to authorised and identified personnel of the consignee.
8. In the event that Custom Officers, Police and/or Immigration Officers require access to the consignment, you shall provide them with your "**Courier Certificate**" and you shall request that this documentation be passed immediately to senior Customs officers, Police and/or Immigration Officers.

In the event that Customs Officers, Police, and/or Immigration Officers demand access to the contents of the consignment, this inspection must be carried out under the supervision of the Courier. The Security Officer responsible for the consignment must be informed.

9. Upon return from delivering the consignment, you are required to provide the issuing Security Officer with the "**Shipment Document and Final Declaration**" duly signed and sealed as a receipt for the consignment signed by the recipient or a duly authorized person, and to sign the "**Declaration by the Courier on Completion of the Carriage / Transport**".

BRIEFING DECLARATION
